ORDINANCE 2012-06

**AN ORDINANCE PROVIDING FOR LEVYING, ASSESSMENT AND COLLECTION OF TAXES
FOR THE FISCAL YEAR BEGINNING MAY 1, 2012 AND ENDING APRIL 30, 2013, FOR THE
DU PAGE COUNTY, ILLINOIS**

WHEREAS, the President and Board of Trustees of the HIGHLAND HILLS SANITARY DISTRICT, Du Page County, Illinois have heretofore passed, adopted and published an appropriation ordinance for the said District for the fiscal year beginning May 1, 2012 and ending April 30, 2013.

NOW, THEREFORE, BE IT ORDAINED by the President and the Board of Trustees of the HIGHLAND HILLS SANITARY DISTRICT, County of Du Page and State of Illinois:

SECTION 1: THAT the fiscal year for HIGHLAND HILLS SANITARY DISTRICT be and the same is hereby fixed and declared to be from the 1st day of May 2012 to the 30th day of April 2013.
