

**HIGHLAND HILLS SANITARY DISTRICT
ORDINANCE #2013-01**

**AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE
HIGHLAND HILLS SANITARY DISTRICT, DUPAGE COUNTY, ILLINOIS**

WHEREAS, the District was formed under and is governed by the Sanitary District Act of 1936, 70 ILCS 2805/1 et. seq.; and

WHEREAS, there is contiguous to the HIGHLAND HILLS SANITARY DISTRICT certain territory to which sanitary sewer and water supply service of the District are presently available; and

WHEREAS, said territory is not within the corporate limits of the Sanitary District, is not within the corporate limits of any municipality, and is contiguous to the Sanitary District; and

WHEREAS, the public interest and the common good will be served by the annexation of said territory to said Sanitary District; and

WHEREAS, the annexation of the territory described herein is specifically authorized by 70 ILCS 2805/32al et. seq.;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE HIGHLAND HILLS SANITARY DISTRICT, DUPAGE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: The territory described in Exhibit A be and is hereby annexed to the HIGHLAND HILLS SANITARY DISTRICT.

SECTION 2: The District Clerk is hereby directed to file in the Office of the County Clerk of DuPage County, Illinois, and in the Office of the Recorder of Deeds, DuPage County, Illinois, a copy of this Ordinance, together with an accurate map of the territory annexed, certified as correct by the Clerk of the District.

SECTION 3: This Ordinance shall be in full force and effect upon its passage and approval as provided by law.
