

**Ordinance 2013-04**

**An Ordinance Amending 2012-02  
Providing for the Regulation and Operation of the  
Waterworks System of the Highland Hills Sanitary District  
DuPage County, Illinois**

WHEREAS, on January 10, 2006 the Board of Trustees of Highland Hills Sanitary District passed Ordinance 2006-01; and

WHEREAS, the Board of Trustees amended said Ordinance pursuant to Ordinance 2009-01 passed April 28, 2009; and

WHEREAS, the Board of Trustees further amended said Ordinance pursuant to Ordinances 2010-05 and 2012-02; and

WHEREAS, the Board of Trustees deems the amendment of Ordinance 2012-02 to be appropriate and fiscally responsible;

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Highland Hills Sanitary District, DuPage County, Illinois as follows:

Section 1: That Article IV Section 6 be amended to read as follows:

Section 6: The following rates are hereby established for water usage from the District's water supply system based upon the amount of water used as indicated by meter readings as follows:

Per Bi-Monthly Period

First 8,000 Gallons (minimum)	\$30.49
Per Thousand Gallons (over 8,000 minimum)	\$ 4.14

The water bill is payable not later than twenty (20) days after the date of the bill. If not paid within such period, a 5% late charge is due and payable. All bills shall be deemed to be delinquent if not paid within thirty (30) days from the due date on the bill.

- a) Any payment submitted by check and returned to the District from the bank for non-sufficient funds or a closed account shall result in a processing fee of \$50.00 being applied to the user and/or owner.

Section 2: That as except as amended hereby Ordinances 2010-05 and 2012-02 shall remain in full force and effect.

Section 3: All Ordinances or parts thereof in conflict with the provision of this Ordinance are hereby repealed.

Section 4: This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law for all bills prepared and issued after October 31, 2013.

Section 5: The Clerk of the District is hereby authorized and directed to cause a certified copy of this Ordinance to be recorded in the Office of the Recorder of Deeds in DuPage County, Illinois.
